GENERAL REGULATIONS

If students submit an application for a session and then subsequently pull out from that session, they must submit another new application for a following exam session.

The student card and a €14.62 duty stamp must be brought to the Student Secretariat some days before the actual exam. Bringing these items allows the student to obtain a certificate detailing that he/she has sat the final degree exam.
