Information about Diploma Supplement

In conformity to DM No. 49 of 26.10.05, all Italian universities have to issue the Diploma Supplement in attachment to the new Italian degrees as from 2005.

The aim of the Diploma Supplement is to supply information improving international transparency and facilitating the academic and professional recognition of qualifications. It is designed to provide a description of the nature, level, context, content and status of the studies that were successfully completed by the student.

The Diploma Supplement is issued upon the student's request. The request can be presented together with the application for the final degree thesis admission or any time after graduation.
