ADMISSION CRITERIA

Admission to the master programme requires the possession of one of the following qualifications:

- a) Italian bachelor degree (*) in one of the following classes or in an equivalent study qualification earned abroad:
- 1. Ex M.D. 270/04: Bachelor degree in the classes:

 - L-17 Scienze dell'Architettura
 - L-21 Scienze della pianificazione territoriale, urbanistica, paesaggistica e ambientale
- 2. Ex M.D. 509/99: Bachelor degree in the classes:
 - 42 Disegno industriale
 - 04 Scienze dell'architettura e dell'ingegneria edile
 - 07 Urbanistica e scienza della pianificazione territoriale, urbanistica, paesaggistica e ambientale
- (*) In every case, Italian citizens with a foreign university degree must have a high school diploma.

d) Bachelor degree, University diploma or equivalent degree of another class or study qualifications earned abroad can be valued as adequate if, during your study career and before the beginning of the admission procedure, you have gained 10 credit points in the following fields: Design, Architecture and Spatial Planning, Landscape architecture, Interior Design, Cinema, Photography or Informatics.

Admission to the Master in Eco-Social Design is also subject to passing the two-step selection procedure.

Stage 1:

The first step is an evaluation of the documents by the Selection Committee presented with the application.

Selection criteria of stage 1:

Portfolio: max 20 points; Outline of a project proposal: max 20 points.

In order to be eligible for the second stage, you must have obtained at least 20 points.

Stage 2:

Interview: max 20 points.

The second stage consists of an interview designed to assess the experience gained. In the interview the following will be discussed: experience in the field of the study programme, inter- and transdisciplinary experiences, innovative and creative thinking, ability to work in team, ability to discuss and to reflect critically.

Candidates must achieve a minimum score of 30/60 total points to be eligible for enrolment.

CONFIRMATION OF STUDY PLACE AND ENROLMENT

If you have been admitted through the ranking list, you must:

- 1) select the degree course in the Application portal and pay with one of the indicated payment methods to confirm the study place within 6 August 2024, 12 (midday). The first instalment of tuition fees amounts to € 773.00.
- 2) until 15 October 2024, 12 (midday), enrol online in the Application portal.

If you do not respect the deadlines, you will automatically lose your place which will be offered to the subsequent applicant in the ranking list.

If by paying the 1st instalment you have confirmed the study place, there will be no refund of the tuition fees.

According to national regulations, simultaneous enrolment in a maximum of 2 programmes is possible (however, the two programmes must not belong to the same class, e.g., LM-18/LM-18 and must differ for at least 2/3 of the course activities).

If you have been admitted to more than one study programme, you can confirm your place for a maximum of 2 programmes by paying the designated fee twice.



If you do not have the required academic qualification, you will be given a conditional offer for a study place, and you must submit your qualification upon enrolment. If you achieve your qualification after the enrolment deadline, you cannot enrol, and you will lose your place which will be offered to the subsequent applicant in the ranking list.

Advice: If you achieve your qualification after the enrolment deadline, you should not pay the tuition fees to confirm the study place. You will be able to submit a late enrolment request and, only if there are study places still available, you can enrol by 13 December 2024.

If you have been admitted in the ranking list, but you do not possess a valid admission qualification, you can be excluded with Rector's decree even after enrolment.

Please note that you do not gain full student status by only paying the tuition fees. This status will only be acquired upon enrolment.

INFORMATION FOR INTERNATIONAL APPLICANTS

If you have gained your qualification abroad, you must upload in the Application portal (if not uploaded upon application):

- the diploma of your qualification;
- the official translation of your diploma into Italian (translation is not necessary if the certificates have been issued in German or English);
- the Diploma supplement, where it must be indicated:
 - o that you have achieved at least 180 credit points (ECTS) and
 - o that the study title gives access to a Master programme.

If you have gained your qualification abroad in one of the Countries that are signatory to the Lisbon Convention you must also upload:

• the Statement of Correspondence of your qualification, to be downloaded from the ARDI - Automatic Recognition Database – Italy

If you have gained your qualification abroad in a country that is not a signatory to the Lisbon Convention, you must also upload:

• the Statement of Comparability and Verification of your qualification, issued by the Italian Information Centre on Academic Mobility and Equivalence (CIMEA)

unibz performs the necessary checks on your foreign qualification and in case of doubt reserves the right to request additional documents.

Please note: If you have gained your qualification abroad and have not uploaded your diploma, you are provisionally admitted until your study title can be verified. You will be excluded if it turns out after verification that your qualification does not meet the requirements and therefore does not permit enrolment.



Please note: If you have declared to be resident in Italy but have not attached to your application a copy of your valid residence permit for Italy (see article 39, paragraph 5 of decree no. 286 of 25.07.1998) you will be excluded from the ranklist.
